### 4. First-aid measures

**Methods and materials for containment and cleaning up** Ensure adequate ventilation. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate protective equipment and clothing during clean-up. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Prevent product from entering drains. Prevent entry into waterways, sewer, basements or confined areas. Stop the flow of material, if this is without risk.

Large Spills: Absorb in vermiculite, dry sand or earth and place into containers. Clean surface thoroughly to remove residual contamination.

## 7. Handling and storage

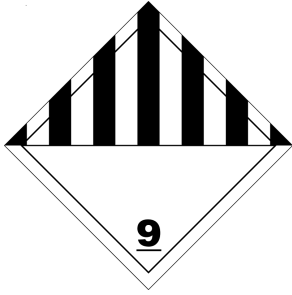

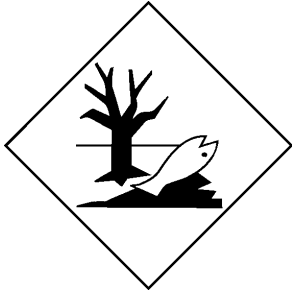
